Removal of one Acer tree one Ash tree one Yew tree and two Pine trees TPO 5 29 Pinfold Close, Tutbury, Staffordshire, DE13 9NJ

in accordance with the submitted documents and plans, for the reason(s) specified hereunder:

Local Plan Policy DP8 states that felling of protected trees will only be granted where the tree is in poor health and/or has lost its intrinsic visual amenity or the tree is causing demonstrable harm/damage to the structural integrity of the building or other built form, and the harm cannot be remedied by other reasonable means. The protected trees which form part of a distinct group are considered to be attractive specimens which are healthy and clearly visible when approaching the site from both directions along Belmont Road. Consequently they have a high degree of visual prominence and make a significant and positive contribution to the character of the area. In the absence of a structural engineers report it has not been proven that any damage caused could not be attributed to any other causes. Therefore, insufficient evidence has been submitted to demonstrate that any remedial measures or mitigation works could be employed to secure the future retention of the trees. The removal of the trees would therefore adversely affect the visual amenity of the locality contrary to Local Plan Policies SP1, DP8, the National Planning Policy Framework (particularly paragraphs 7 and 17 and Section 11) and guidance contained in Tree Preservation Orders: A Guide to the Local and Good Practice.

There are at least 2- tree saplings missing. Mick found one – snapped off & thrown in the nettles.
