Former camps such as Fauld have no footpath, cycle lane or bus service to access them from nearby communities. There have been accidents and road deaths on the C91 Fauld Road, a similar situation can be seen on the Draycott-in-the-Clay/Marchington Road.

Other rural enterprises bring similar increases in road usage on to roads not designed, built or maintained for such traffic.

Employees of countryside enterprises are at risk if they walk or cycle and are disadvantaged when seeking employment if they cannot drive.
